Table 2. Findings:

- Due to misrepresentation of authorized appointed person to represent RDI construction and non -compliance to the minimum documentary requirements, insufficient proof to construct and implement the offered project in accordance with the specifications , the BAC Members and TWG Members unanimously declared the second bidding as
- 2. It was recommended that re-posting of the project details in PHILGEPS be done in compliance to RA 9184 and it's Implementing Rules and Regulations for second failed bidding and resort to "Negotiated Procurement" (IRR-A Sections 35.3 and 53.1).

It is recommended by the TWG that a reposting of the project for bidding in the PHILGEPS be conducted in order to invite other interested and qualified construction firms and join the bid activities as prescribed in the IRR of RA 9184 for Two failed bidding resulting to "Negotiated Procurement".
