WHEREAS, after two failed biddings, the UNIVERSITY scheduled the Conference for Negotiated Procurement of the said project;

WHEREAS, in response to the said invitation, two (2) contractors attended the Negotiation Conference on February 22, 2021 namely:

2. ELIJENRAE Builders and Construction Supply;

WHEREAS, the Bids and Awards Committee for “**Construction of Cavite State University-CCAT Campus Welcome Arch**” conducted the negotiation for the said project on March 17,2021 at 2:00 p.m. in CvSU-CCAT Hostel;

WHEREAS, ELIJENRAE Builders and Construction Supply appeared and submitted the bid documents on the scheduled date of the negotiated procurement;

WHEREAS, during the opening of the technical requirements and after careful examination, the BAC found out that ELIJENRAE Builders and Construction Supply, possessed all the necessary technical components of the bid requirements;




