**BAC Resolution Declaring Failure of Bidding for Opening of Bid for
“Supply and Delivery of ICT Supplies and Equipment for CvSU CCAT EI Studio”**

Resolution No. 02, s. 2022

WHEREAS, the UNIVERSITY has programmed the “*Supply and Delivery of ICT Supplies and Equipment for CCAT EI Studio*” at CvSU CCAT Campus with Approved Budget for the Contract of Three Million One Hundred Fifty Thousand Four Hundred Forty-Nine & 26/100 (Php 3,150,449.26).

WHEREAS, the UNIVERSITY advertised Invitation to Apply for Eligibility and to bid for the said project in the Phil-GEPS and in conspicuous places continuously from December 3, 2021 to January 5, 2022.

WHEREAS, in response to the said advertisement, Masangkay Computer Center bought the bidding documents and appeared on the scheduled date of the bid.

WHEREAS, the Bids and Award Committee with Technical Working Group conducted mandatory review and evaluation of the terms, conditions and specifications and ascertained Masangkay Computer Center failed to comply the bid requirements.


WHEREAS, according to the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Otherwise Known as the Government Procurement Reform Act, **Section 35. B. Failure of Bidding**, the BAC shall declare the bidding a failure when “prospective bidder declared ineligible”;


WHEREAS, upon careful examination, validation and verification of the provisions of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC Chairperson, proclaim the bidding as **"FAILURE OF BIDDING"**.


WHEREAS, the Committee agreed for the conduct of second bidding. If the rebidding fails for the second time, the committee will resort to **"Negotiated Procurement"** (IRR-A Sections 35.3 and 53.1).

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare the bid of **"Supply and Delivery of ICT Supplies and Equipment for CCAT El Studio"**, **FAILED**.


