**BAC Resolution Declaring Failure of Opening of Bid for
“Supply and Delivery of Information Technology Equipment (Fund 2021)”**

Resolution No. 117, s. 2022

WHEREAS, the UNIVERSITY has programmed the “*Supply and Delivery of Information Technology Equipment (Fund 2021)*” at CvSU CCAT Campus with an Approved Budget for the Contract of One Million Four Hundred Eighty-three Thousand Six Hundred Sixty-four pesos (1,483,664.00).

WHEREAS, the UNIVERSITY advertised an Invitation to Apply for Eligibility and to bid for the said project in the Phil-GEPS and in conspicuous places continuously from August 3, 2022, to August 30, 2022.

WHEREAS, no response to the said advertisement, no prospective bidder expressed their intention and appeared on the scheduled date of the Opening of the bid last September 2, 2022.

WHEREAS, according to the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Otherwise Known as the Government Procurement Reform Act, *Section 35.1.A. Failure of Bidding*, the BAC shall declare the bidding a failure when “*no bids are received*”;

WHEREAS, upon careful examination, validation and verification of the provisions of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC Members, decided to proclaim the bidding as “*FAILURE OF BIDDING*”;


WHEREAS, the Committee agreed to the conduct of second bidding with re-advertisement and/or posting as provided for in Section 21.2 of *Implementing Rules and Regulations*.

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare ***“Supply and Delivery of Information Technology Equipment (Fund 2021)”***, **FAILED**.
