**BAC Resolution Declaring Failure of Opening of Bid for  
“Supply and Delivery of Information Technology Equipment (Fund 2022)”**

Resolution No. 182, s. 2022

*WHEREAS*, the UNIVERSITY has programmed the “*Supply and Delivery of Information Technology Equipment (Fund 2022)*” at CvSU CCAT Campus with an Approved Budget for the Contract of Two Million Twenty-three Thousand Thirty-four pesos and 05/100 (PHP 2,023,034.05).

*WHEREAS*, the UNIVERSITY advertised an Invitation to Apply for Eligibility and to bid for the said project in the Phil-GEPS and conspicuous places continuously from October 3, 2022, to October 28, 2022.

*WHEREAS*, in response to the said advertisement, JJAM Trading bought the bidding documents and virtually appeared on the scheduled date of the bid.

*WHEREAS*, the Bids and Award Committee with the Technical Working Group conducted a mandatory review and evaluation of the terms, conditions, and specifications and ascertained that JJAM Trading failed to comply with the bid requirements.

*WHEREAS*, according to the updated 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Otherwise Known as the Government Procurement Reform Act, *Section 35.1.A. Failure of Bidding*, the BAC shall declare the bidding a failure when “*All bids fail to comply with all the bid requirements or fail post-qualification*”;


*WHEREAS*, upon careful examination, validation, and verification of the provisions of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the BAC Members decided to proclaim the bidding as “*FAILURE OF BIDDING*”;

WHEREAS, the Committee agreed to the conduct of "*Negotiated Procurement*" as specified in the updated 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, Section 35.5.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare "*Supply and Delivery of Information Technology Equipment (Fund 2022)*" **FAILED.**
